

Information About the Treatment of Personal Data Using Cookies

What are cookies

Cookies are small text files which collect information in your browser and are mostly used to identify the different users. You can imagine cookies to be a sort of a memory of the website which by using them will recognize the computer when a user next opens that web. But the user's identity cannot be found based on those cookies.

Cookies do not take almost any place on the disk of your computer, their size is usually of about just a couple kilobytes. Cookies are not used to get any sensitive personal data.

Standard web browsers support the management of cookies. For a more detailed information please use the help of your browser. If your browser allows the use of cookies, we will suppose that you agree with the use of standard cookies on our servers.

Information/Instruction

1. **The company RRR Consulting s.r.o.** with its seat at Salvátorská 931/8, 110 00 Praha 1, ID Number 03771083, registered with the Commercial Register administered by the Municipal Court in Prague under File No. C- 237536 (referred to as „Guarantor“), being the operator of the NestDo.com website is using this website's cookies for the following goals:
 1. *Measuring the number of visitors and statics of their numbers and their behaviour on the website;*
 2. *Smooth functioning of the website;*
 3. *Targeting promotion and advertisement to the users that agree with it.*
2. Collecting cookies for the goals described in Paragraph 1 can be considered personal data treatment. Such treatment is made possible based on lawful reasons, namely a legitimate interest of the Guarantor made possible by the Article 6 (1) (f) of Regulation (EU) No 2016 /679 of the European Parliament and of the Council on the Protection of Individuals with regard to the Processing of Personal Data and on the Free Movement of such data, and repealing Directive95/46/EC (General Data Protection Regulation) (the Regulation).
3. The webpage can also be used in a regime which doesn't allow for the collection of data about the behaviour of the web's visitor. It is possible to set this condition either directly in the set-up of your browser or it is possible to protest against such a collection based on legitimate interest following number 21 of the Regulation, by sending it to the contact address info@rrrconsulting.edu. Your objection will be evaluated without any delay, within 30 days at most, or 2 months in a legitimate case. The cookies necessary for the functionality of the web will be kept only as long as needed for the web's functioning.
4. When objecting against collection of technical cookies necessary for the functioning of the website, we cannot guarantee you a full functionality and compatibility of the websites.

5. Cookies, which are collected to measure webvisitation and produce statistics on visitors' attendance and behaviour on the web, are assessed in a bulk and anonymized form that allows identification of an individual only when considerable and professional efforts are made.
6. The use of marketing cookies requests your consent. You are giving the consent for a period of 5 years.
